**Subject:** Reply to RTI Application No. FCIHR/R/E/25/00095 dated 08.10.2025

Sir/Madam,

With reference to your RTI application cited above, it is informed that the information available on record in this office has been examined. Based on the records furnished by the concerned, the factual status of cases related to the subject matter is as under:

S.No.	Firm Name	Action Taken / Status
1.	M/s R.K. Agro Poly Industries, Rajpura	The contract awarded to the firm was terminated due to violation of MTF clause and failure to supply the requisite LDPE covers. Consequently, Security Deposit and Bank Guarantee were forfeited. The debarment imposed on the firm was withdrawn on 26.11.2024 under the <i>Vivad Se Vishwas – Relief for MSMEs</i> scheme.
2.	M/s Bag Poly International Pvt. Ltd.	The firm is involved in ongoing litigation with FCI Haryana Region: (i) CS 1097/2023 filed by the firm in Civil Court, Panipat – next hearing on 03.11.2025; and (ii) Civil Revision 120/2025 filed by FCI through DM Karnal – adjourned till 08.12.2025. Both cases are pending adjudication.

As the information sought includes **copies of all documents** relating to debarment, forfeiture, and litigation of private firms, the same falls under the ambit of **third-party information** in terms of *Section 11* of the RTI Act, 2005. Disclosure of such documents requires prior written notice to the concerned third parties and consideration of their representations, if any, before disclosure.

Further, certain information pertains to **ongoing court proceedings**, and disclosure of related records at this stage may attract exemption under *Section 8(1)(h)* of the RTI Act, 2005, as it may impede the process of adjudication.

Accordingly, while the factual information as stated above is being provided, the underlying documentary records are **cannot be furnished at this stage**, in view of the provisions of Sections **8(1)(h)** and **11** of the RTI Act, 2005.

You may, however, exercise your right to appeal under *Section 19(1)* of the RTI Act, 2005 within 30 days from the receipt of this reply, if you are not satisfied with the information provided.
